## Article 1: Legal Definition

The party responsible for processing data is hereafter called the "controller".

# Article 2: Processing Of Personal Data

- 1. Personal data means any information relating to an identifiable or identified natural person (data subject)
- 2. An identifiable natural person is who can be identified, indirectly or directly, by reference to an identifier, such as a name, an identification number, location data, online identifier, or to one or more factors specified to genetic, physiological, physical, economic, mental, cultural, or social identity of the natural person.
- 3. We process the following personal data from you as provided by you:
  - a. Your first and last name;
  - b. Your email address;
  - c. Your mailing address;
  - d. Your telephone number;
  - e. Your hosting login, in case we need to access the hosting to setup WordPress;
  - f. Your Browser based data to provide the best possible viewing experience;

#### Article 3: Purpose Of Processing

We do not collect your personal data without a purpose. Your personal data are processed for:

Answering your inquiries, submitting offers, order processing, and sending invoices by mail, or e-mail.

## Article 4: Registration Of Persona Data

Your personal data are recorded in an (electronic) register.

## Article 5: Your Rights Regarding Your Information

- 1. Pursuant to Article 13(2)(f) GDPR each data subject has the right to request from the controller access to and rectification or erasure of personal data or registration of processing concerning the data subject or to object to processing as well as the right to data portability.
- 2. You can exercise there rights by contacting us via email at ulimontague@gmail.com.
- 3. Within one month of the submitted request, you will receive an answer from us.
- 4. Depending on the complexity and the number of the requests this period may be extended to 60 days.

## Article 6: Legal Obligations

In case of infringement of any law or regulations, of which a visitor is suspected and for which the authorities require the personal data collected by the controller, they will be provided to them after an explicit and reasonable request of those authorities, after which these personal data do not fall under the protection of the provisions of this Privacy Policy anymore.

#### **Article 7: Commercial Offers**

- 1. You may receive commercial offers from the controller. In most cases these commercial offers are directly related to your formerly submitted inquiry or order.
- 2. If you do not wish to receive these commercial offers (anymore), please provide the form of communication you wish us to stop by email to ulimontague@gmail.com.
- 3. Your personal data is not to be used by our partners for commercial purposes.

#### Article 8: Data Retention

The collected data are used and retained for the duration determined by law.

#### Article 9: Applicable Law

The conditions in this Privacy Policy are governed by Dutch law. The court in the district where the controller is registered and does business has sole jurisdiction if any dispute regarding these conditions may arise, except if a legal exception applies.
